## ARNOLD, "OUTSTANDING TEAM MEMBER", RETIRED FROM PROSECUTOR'S OFFICE <u>FOR IMMEDIATE RELEASE</u> February 10, 2025

Assistant Prosecuting Attorney John J. Arnold retired on Friday, February 7, 2025, after 42 years of combined service with the Warren County Prosecutor's Office and the Hamilton County Prosecutor's Office.

During his time as an assistant prosecutor, John served in both the Criminal and Civil Divisions, and prosecuted many high-profile cases on behalf of the Office, including the prosecution of Marcus Isreal for the murder of Warren County Sheriff's Office Sergeant Brian S. Dulle, the death penalty conviction of Austin Myers for the aggravated murder of Justin Back of Wayne Township, and the conviction of Mohammed Laghaoui for the attempted murder of Warren County Sheriff's Deputy Katie Barnes.

In addition to his service as an assistant prosecutor, John also served as a Captain and later as a Lt. Colonel in the Judge Advocate General's Corps of the United States Army. John is also heavily involved in the local agricultural community, specifically the Warren County Farm Bureau and 4-H programs.

Before announcing his retirement, John also received the Warren County Prosecutor's Office's highest honor, the 2024 "Outstanding Team Member Award", from his peers. In their nominations, John's colleagues had the following comments about him:

"John is always willing to talk through a case with a less experienced attorney, and he is approachable for advice. Not to mention, he has a great variety of knowledge of many areas of the law. Even though we work in different divisions, he always asks, 'what's going on in your world?' and he truly wants to know, and he usually also has a nugget of advice because he's handled the same kind of matter sometime in his own vast experience. His guidance is always welcome and valued."

"Although I have never actually been assigned as his legal assistant long term, I have had the occasional opportunity to provide coverage for him over the years. John is one of my favorite attorneys to work with and I mean that wholeheartedly. I very much like the fact that John is decisive and knows what he wants and that makes him easy to work with because he has clear expectations. That alone is probably enough to make him outstanding in my eyes this year."

He has a depth and breadth of legal knowledge and courtroom experience that is unrivaled. John is the first attorney in the office I turn to when I need to discuss a legal or factual issue. He is always willing to discuss cases and problem solve solutions and always shares the benefit of his considerable experience with others. He is a mentor, colleague and role model."

I hope he knows the depth of his impact not only on myself but on everyone that surrounds him."

John truly raises the bar for our office, he provides leadership and sets an example of professionalism that we should all strive for, and he makes our office a better place to work for every staff member.

So, what we truly know about that sometimes grumpy, very seasoned attorney that came here from that county to the south of us, is that his tough façade is just that...a façade...and when he does decide to say goodbye and close this chapter, Papa Bear will be incredibly missed by all!"
